



HEALTH CENTER BILLING POLICY

Zepf Center's Health Center Program (HCP) services are available to all patients without regard to residence or ability to pay. Sliding fee discounts are available for HCP services based solely on household size and income.

Patients will be mailed a monthly statement for balances remaining after insurance payments and/or sliding fee discounts have been applied. Payment is due within 30 days.

Patients with balances over 60 days may be subject to collection proceedings and discharge from the agency for refusal to pay. We will never deny services due to an inability to pay.

Please contact us if your financial situation has changed, you need to arrange for a payment plan or would like to file a hardship application. We can also assist with the application process for Ohio Medicaid for those who appear to be eligible.
